## Dr. Robert G. Rifkin presents

### "A Retrospective Review of Long Term Restorative Procedures" Wednesday, October 30th, 2013

### ABOUT THE TOPIC

Creating natural-appearing, attractive, and healthy smiles is a complex task requiring a multi-factorial approach. It begins with the face. Facial analysis is as old as civilization, however today there is a vast array of modern techniques to help complete this study. Unfortunately, we as dentists often concentrate only on the teeth. We commonly overlook an analysis of the anterior, lateral, and oblique facial skeletal relationships, soft tissue and tooth angulation in our planning. The results are often functionally correct, but esthetic failures. Today, the utilization of full mouth radiographs and diagnostic casts is not enough when developing a treatment plan.

Orthodontists, maxillofacial and plastic surgeons devote a great deal of their time analyzing cephalometric concepts and soft tissue profiles. As restorative dentists, we also need to consider this neglected dimension.

Highlights of various restorative procedures will also be discussed.

It is a difficult task to create restorations that are not only attractive but also functionally designed to provide long lasting results. Only when all of these parameters are considered are we able to reach the restorative vision.



### Muscle Referral Patterns - Orofacial Pain 101

patient presents to your office complaining of pain with and without chewing, and she is pointing to the outside of her jaw in the area of #18. You do an exam and obtain imaging but there is nothing you see to be able to account for her pain. Instead of scratching your head or referring the patient to a psychologist because you can't account for the pain, start to think about myofascial pain. Myofascial pain is pain from muscles that refer pain to a remote site. In dentistry, the site and source of a patient's pain is almost always the same. They can tell you where it hurts, and your exam and imaging confirms why the patient is having pain. In orofacial pain, the site and source are almost never the same. Knowing the muscle referral patterns greatly expands the knowledge of a dentist and helps account for some pains that previously did not make any sense.

### Here are the muscles that can refer pain to teeth.

- The lower part of the superficial masseter can refer pain to the mandibular molars.
- The upper part of the trapezius can refer pain to

the angle of the jaw.

- The upper part of the superficial masseter and the posterior temporalis can refer pain to the maxillary molars.
- The middle temporalis can refer pain to the maxillary canine and premolars.
- The anterior temporalis can refer pain to the maxillary anteriors.
- In other words, the temporalis can cause pain in all the maxillary teeth on the ipsilateral side.
- The anterior belly of the digastric can refer pain to the mandibular anterior teeth, and the pain can cross the midline.

Most of the muscles that cause tooth pain are the closing muscles, with the exception being the anterior belly of the digastric, which is an opening muscle. If the pain is from myofascial pain, you should be able to replicate the pain with palpation of the muscle. Hold the palpation for 6-10 seconds at 2-4 kg/cm2 pressure, which is very firm pressure.


